Adult Pool & Spa Program Proves Early Success

The Pilot Program, keeping the adult pool and spa open for residents in the off-season, is proving a huge success. The program will continue through November 20, 2022.

Please note that this program is employed with a swim-at-your-own risk policy — and each individual accessing the adult pool and spa must use VIZpin at the gate. Keeping an accurate and up-to-date headcount, and knowing how many people are taking advantage of this program, will be important as we determine the district's ability to offer this program in the future.

Stonegate North Villages Snow Removal Policies

The district contracts with an independent company to clear all right-of-way sidewalks on, or adjacent to, common tracts owned by the district. They also clear the main park sidewalks and manage snow removal for the two parking lots adjacent to the pool and tennis courts, as well as the park at the southeast corner of Keystone Boulevard and Aventerra Parkway.

Snow removal operations are triggered anytime there is an accumulation of more than two inches in depth. Additionally, the district's contract with our provider calls for their teams to begin snow removal operations within twelve hours after snowfall has ceased, or as conditions safely permit.

It is important to note that snow removal on the adjacent public streets throughout the district are maintained by Douglas County.
